

Whereas the "SRI SRINIVASA EDUCATIONAL TRUST" corpus fund shall be Rs.1001/- (Rupees One thousand One only) to form the trust and whereas the Trustees above named have agreed to accept the said Trust on terms and conditions set forth herein:


NOW THE DEED OF TRUST WITNESSETH:

1. The Name of the Trust shall be "SRI SRINIVASA EDUCATIONAL TRUST".
2. The Registered office of the Trust shall be S.R.V.THOTTAM, MOOLAKADU VILLAGE, MASAKALIPATTY PO, RASIPURAM TK, NAMAKKAL DISTRICT.
3. The term trustees shall mean the Trustees from time to time prescribed by the said trustees belonging to "SRI SRINIVASA EDUCATIONAL TRUST".
- 4.a. The Trustees of the Trust hereby declare a sum of Rs.1001/-(Rupees one thousand one only) as the Trust property and assign, transfer and deliver the same to the Board of Trustees who shall hereinafter stand possessed of the aforesaid Trust property and funds (which expression where ever the context permits in cash or in kind or in any nature whatsoever into and for which the said property or any part thereof may from time to time be converted, varied acquired or exchanged and or such other investments as may be held by the board of Trustees from time to time in relation to these presents with all incomes, thereof by using and or investing such property) upon Trust for the objects setout herein and subject to the provisions and conditions hereinafter contained in these presents.



The Trustees of the Trust hereby declare that the Board of Trustees shall hold the Trust properties for fulfilling the objects enshrined in the Trust Deed and shall not have any manner of right, title, claim or interest whatsoever in or upon the Trust property, the corpus and income of the Trust personally,


5. The objects of the Trust are:

- (a) To establish and maintain Schools, College of Arts and Science, Professional, technical, Medical and Agricultural Colleges, Hostels, Study circles, Libraries, Reading Rooms, Lecture Halls, etc.,
- (b) To establish and maintain Creches and Women Hostels.
- (c) To establish and maintain Schools for Physically handicapped children.
- (d) To establish and maintain Adult Education and Computer Education centres.
- (e) To establish and maintain shelters for old aged people, destitute street children and for people seeking peace of mind, irrespective of case, creed and community.
- (f) To arrange and conduct training programmes, refreshers, short and long term seminars, workshops and the like for persons and Teachers who are in the Educational field at the request of Government Public Sector, or Private Institutions.
- (g) To conduct consultancy service to Government or Institutions National or International, to do propaganda, publicity and other services and to conduct functions and sponsor programs connected with Educational field.
- (h) To organize seminars on National Integration, celebrate birthdays of national leaders like Mahatma Gandhiji, Nehru, Dr.Radhakrishnan, Kamarajar, Indira Gandhi, Anna, MGR, Rajiv Gandhi etc., and to organize photo exhibition on national leaders and national movement.
- (i) To organize cultural programs on National movement and Indian civilization.
- (j) To organize Co-operative Society or societies for the benefit of students and Teachers.
- (k) To co-operative and function with any other society, Trust, Institution or any other organization having similar objects of National or International.






- (l) To create and maintain Magalir Mandrams and Youth clubs in urban and Rural areas.
- (m) To subscribe to any other Association or Institution to benefit the Trust or persons employed by the Trust.
- (n) To take rent, lease or mortgage any property, premises, buildings or assets and likewise to let on rent or lease or mortgage any property, premises, building or any other assets are belonging to the Trust.
- (o) To acquire land, buildings and other movable and immovable properties by buying, receiving donations, assignments and alienations, to keep and maintain, improve renovate and or rebuild constructions and to sell, mortgage or otherwise dispose off such properties with a view to implement the objects of the Trust.
- (p) To accept donations both in cash and in kind and gifts of immovable and movables to foster the objects of the Trust.
- (q) To invest, dispose off, transfer and otherwise deal with the subject matter of the Trust in such manner the trustees deem fit so as to enable the trust to carry on its objects.
- (r) To dispose off movable and immovable properties of the trust for the benefit of the Trust.


6. The number of the Trustees shall not be less than 6(Six) and not more than 21(Twenty one).




- b. The Board of Trustees shall be for the life time Trustees unless in their uncontrolled discretion feels that they shall co-opt to any other persons of their legal heirs. The Trustees shall have power unanimously to co-opt any person as a Trustee who shall hold office till such time the Life Trustees agree unanimously from time to time.
- c. Tenure of Office of the Managing Trustee shall be for a period of 5 years. Vacancy arising in the office of Trustees of Managing Trustee by reason of resignation, death, shall be filled by appointing any of remaining Trustees unanimously.
- d. In the event of death of any of the trustees without nominating his/her successor, his wife/husband if he/she survives him/her shall succeed him/hers as Trustee after him/her the senior most son of his/her lineal descendents will be Trustee until such time he prays or divest himself/herself of Trusteeship. After his time the true of seniority of lineage will prevail. In case no son is born the senior most Daughter and her lineage will prevail.
- e. In case any of the Trustee mismanages the Trust funds, the majority members out of the participants in the Board of Trustees meeting can remove the Trustee from Trusteeship and appoint any New trustees with the consent of the remaining trustees to fill up the vacancy.
7. The day to day conduct and management of the affairs of the Trust shall be carried out on by A.R.Duraisami, who shall be known as the "MANAGING TRUSTEE".
8. The Managing Trustee shall have the power:
- a) To receive and keep all Trust Funds and money by way of gifts, donations, contributions, borrowings and grants and other assets of the Trust.
- b) The Managing Trustee shall have the power to open Bank Account in the name of the Trust in any nationalized Banks/Post Office/Co-operative Banks and to operate the same.
9. The Trustees shall have the power:
- a) The trustees shall have power to appoint or terminate such Staff and employees to carry out the object of the Trust.
- b) The trustees shall have power to frame Rules and Regulations unanimously for the proper administration and functioning of the Trust.
10. The trustees shall be entitled to invest the Trust money according to their discretion either with Banks or Post Offices or Co-operative Banks or on the first mortgage of immovable property or purchase of immovable property.





11. The Trustees shall have power to borrow within reasonable limits, from time to time, in the ordinary course of conduct of the trust if in their opinion, it is necessary to borrow for in furtherance of the objects of the Trust by mortgaging or charging the properties.
12. The trustees shall have power to dispose off or sell movable and immovable properties of the Trust for the benefit of the trust.
13. The trustees shall not be entitled to any remuneration or benefits either by way of sitting fees or otherwise for service rendered as Trustees but they will be entitled to be paid such reasonable Traveling expenses and Boarding expenses as may be incurred by them for attending the meeting of the Trust and other services rendered for the Trust and the sums to be so paid shall be decided from time to time by the Board of Trustees and will be payable out of funds of the Trust.
14. The activities of the Trust confined only within Indian territories.
15. The trustees shall keep true and correct account of all the Trust Money and disbursement thereof and the Accounts shall be closed on 31st March every year and Audited by a Chartered Accountant duly appointed and approved by the Trustees.
16. No immovable and moveable property is involved in the Deed of Trust except the initial corpus fund of the trust.
17. Investments of the funds will be in accordance with section 11(5) read with sec.13(1)(d) of the Income Tax Act.
18. Any amendment to this deed shall be carried out with the previous approval of the Commissioner of the Income Tax.
19. In the event of dissolution of the Trust, the Trust properties and liabilities held by the Trust shall be transferred to a trust or Charitable Institution having similar objects and the decision of the Trustees, in this respect, shall be final.
20. It is hereby expressly declared that the Trust is absolute and Irrevocable.
21. The Registered office of the Trust shall be S.R.V. THOTTAM, MOOLAKADU VILLAGE, MASAKALIPATTI PO, RASIPURAM TK, NAMAKKAL DT. at such shall place or places the Trustees may be mutual consent agree from time to time.
22. The income of the trust will be solely utilized towards the objects of the trust and no portion of it will be utilized for payment to the trustees/Members , by way of profit interest, dividend etc.






